## Aikido Seminar

Instruction led by **Greg Tetsuzan Noble Sensei, 6th Dan Aikikai, ZAA Chief Instructor**

**Greg Tetsuzan Noble Sensei** is the Chief Instructor of Zenshinkai Aikido Association. He began his Aikido training at the early age of fifteen, and is now ranked Rokudan (6th degree black belt) Aikikai. He also holds black belt ranks in Muso Jikiden Eishin-ryu Iaido and Shindo Muso-ryu Jodo, and has long-term formal training in Zen. Noble Sensei is a certified Zen Teacher and Roshi under Zen Garland, an international organization for Zen training, and is Dharma Successor of Paul Genki Kahn Roshi.

**Jikishinkan Dojo** has been dedicated to teaching Aikido and Zen meditation for over thirty years. The dojo follows the tradition of its founder, Sensei Joseph Jarman, and his teacher, Shihan Fumio Toyoda. The name Jikishinkan ("direct mind") was given to the dojo by Shihan Toyoda, and reflects the dojo's emphasis on the overlap between Buddhist teaching and Aikido.
